The Winnebago County Finance Committee presents the following Ordinance amending the Annual Appropriation Ordinance for the fiscal year ending September 30, 2024 and recommends its adoption.

# **Ordinance for a Budget Amendment ARP Revenue Replacement**

WHEREAS, the U.S. Treasury allowed American Rescue Plan (ARP) fund recipients use of up to \$10 million of the award for revenue replacement and the County wishes to transfer the remaining portion of their unused amount to the General Fund. The Treasury also does not require recipients to report interest earned on those funds. The County desires to transfer earned interest from the ARP fund to the Capital Improvement Fund for future needs; and

WHEREAS, the Winnebago County Board adopted the "Annual Budget and Appropriation Ordinance" for the fiscal year ending September 30, 2024 at its September 28, 2023 meeting; and

WHEREAS, 55 ILCS 5/6-1003 (2014), states, "After the adoption of the county budget, no further appropriations shall be made at any other time during such fiscal year, except as provided in this Act. Appropriations in excess of those authorized by the budget in order to meet an immediate emergency may be made at any meeting of the board by a two-thirds vote of all the members constituting such board, the vote to be taken by ayes and nays and entered on the record of the meeting."

**NOW, THEREFORE, BE IT ORDAINED**, that the County Board deems that pursuant to provisions as set forth in 55 ILCS 5/6-1003 (2014), certain conditions have occurred in connection with the operations of the County which are deemed to be immediate emergencies; therefore, the increases detailed per the attached Request for Budget Amendment are hereby authorized for Amendment **#24-003 ARP Revenue Replacement**.
