- **B.** Following are highlights of Winnebago County's adherence with program BMPs:
 - 1. Public Education & Outreach: The County maintains the Winnebago County Stormwater Management website.
 - 2. Public Participation/Involvement: The County participates in the Northern Regional Groundwater Protection Planning Committee, the South Fork Kent Creek Watershed Technical Advisory Council, the Technical Advisory Group of the Regional Strategic Land & Water Plan for NW Illinois, and the Water Resources Group of the Regional Planning Council Environmental Committee
 - 3. Illicit Discharge Detection & Elimination: The County obtains, reviews, and, as appropriate, takes action on field observation reports by operations and professional staff. The County is actively involved in making improvements in drainage basin data to improve the ability to assess impact areas.
 - **4.** Construction Site Runoff Control: The County has made provisions for Construction Site Runoff Control, including plan reviews and field inspections, and Sediment & Erosion Control requirements in the County's Surface Water Management Ordinance. The County is in the compliance and enforcement monitoring phase as indicated in the County's NOI.
 - 5. Post-Construction Runoff Control: The County has made provisions for pre-construction review and construction and post-construction inspection of stormwater management features of projects. The County's Surface Water Management Ordinance encourages developments that incorporate post construction runoff quality controls which benefit water quality and prevent:
 - a. creation of any surface water nuisances or hazards; or
 - b. contamination of groundwater.
 - **6. Pollution Prevention/Good Housekeeping:** The County has numerous practices in place and continues to review current operations regarding and research, benefits, and appropriateness of best available practices.
- C. No monitoring data was collected.

D. Storm water activities conducted during the report period include:

- 1. Inlet installation at Guilford Road at Shiloh Road
- 2. Detention pond channel improvement at Macktown salt storage facility
- 3. Berm/ditch regrading at Mulford R.O.W. south of Harrison Avenue
- 4. Culvert slopewall stabilization at Newburg Road west of Perryville Road
- 5. Culvert extension at 4440 Charles Street
- 6. Storm sewer repair at 4826 Charles Street
- 7. Berm/ditch regrading at 4914 Charles Street
- 8. Meridian Road Culvert replacement (South of Montague Rd), by Tipple Rd
- 9. Meridian Road culvert replacement North of Latham Rd
- 10. Manhole reconstruction on Riverside just East of Sage Drive
- 11. Ditch/drainage-way re-grading on the southbound side of Perryville halfway between Mulford Road and Windsor Rd.
- 12. Ditch regrading on the northbound side of Perryville just North of Nimtz Road
- 13. Pipe culvert extension on South Perryville Road just North of bridge over Railroad tracks
- 14. New box culvert on Weldon Road at Cunningham Road
- 15. Pipe culvert replacement and inlet reconstruction on Latham Road at Owen Center Road
- 16. Pipe Culvert extension on Latham Road between Owen Center Road and Rockton Ave
- 17. Wingwall stabilization on South Mulford Road North of Sandy Hollow Road (by RR tracks)
- 18. Pipe Culvert replacement on Steward Road just West of Owen Center Road
- 19. Pipe culvert replacement on Hoisington Road by RR crossing
- 20. Ditch re-grading on Perryville road, west side just North of Rote Road (by driving range)
- 21. Ditch regrading on the East side of Forest Hills Road just South of Riverside Boulevard
- 22. Inlet Reconstruction on Forest Hills Road just South of Riverside Boulevard
- 23. Cleaning and flushing road inlets and storm sewer on Spring Creek Road between Mulford Rd and Reid Farm Road
- 24. Replacement of two road culverts on Telegraph Road
- 25. Replacement of three road culverts on Durand Road
