Report Period: March, 2021 to March, 2021:

- **A.** No changes.
- **B.** Following are highlights of Winnebago County's adherence with program BMPs:
  - 1. Public Education & Outreach: The County maintains the Winnebago County Stormwater Management website. Due to COVID-19 the County was only able to be involved in the Youth Groundwater Festival (groundwater model & enviroscape) on March 10, 2020 and the Soil Erosion & Sediment Control Webinar Series on February 11 & 18, 2021.
  - 2. Public Participation/Involvement: The County participated remotely in the Northern Regional Groundwater Protection Planning Committee, the South Fork Kent Creek Watershed Technical Advisory Council, the Technical Advisory Group of the Regional Strategic Land & Water Plan for NW Illinois, Water Resources Group of the Regional Planning Council Environmental Committee, and the Rock River Watershed Group.
  - **3. Illicit Discharge Detection & Elimination:** The County obtains, reviews, and, as appropriate, takes action on field observation reports by operations and professional staff. The County is actively involved in making improvements in drainage basin data to improve the ability to assess impact areas.
  - **4. Construction Site Runoff Control:** The County has made provisions for Construction Site Runoff Control, including plan reviews and field inspections, and Sediment & Erosion Control requirements in the County's Surface Water Management Ordinance. The County is in the compliance and enforcement monitoring phase as indicated in the County's NOI.
  - **5. Post-Construction Runoff Control:** The County has made provisions for pre-construction review and construction and post-construction inspection of stormwater management features of projects. The County's Surface Water Management Ordinance encourages developments that incorporate post construction runoff quality controls which benefit water quality and prevent:
    - a. creation of any surface water nuisances or hazards; or
    - b. contamination of groundwater.
  - **6. Pollution Prevention/Good Housekeeping:** The County has numerous practices in place and continues to review current operations regarding and research, benefits, and appropriateness of best available practices.

- C. No monitoring data was collected.
- **D.** Storm water activities planned during the next report period include:
  - 1. Storm Water Management Plan for Winnebago County:
    - Complete & adopt in 2021.
  - 2. Storm Sewer Mapping & Inspection Project:
    - Spring 2021 Summer 2023: complete field data & inspections.
    - Summer 2023 Spring 2024: compile data & complete Asset Database & GIS Mapping.
    - Summer 2024: initiate outlet inspections, system repairs, and maintenance schedule.
- **E.** Winnebago County is solely responsible for our program.

  - **4.** 5/20/2020 Replace 18"x64' road culvert on Meridian Road 625' south of Montague Road.
