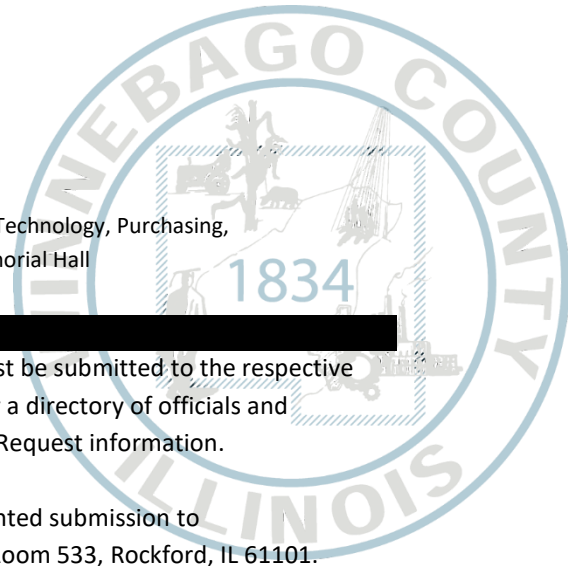


# Freedom of Information Act (FOIA) Request
