AMENDMENT NO. 1 TO AGREEMENT FOR JANITORIAL SERVICES BETWEEN WINNEBAGO COUNTY, ILLINOIS AND ADVANCED CLEANING

This Amendment No. 1 (hereinafter the "Amendment") is made and entered into this 11TH day of May, 2017, by and between Winnebago County, Illinois, with an address of 404 Elm Street, Rockford, Illinois (hereinafter the "County") and Advanced Cleaning, with an address of 3815 North Mulford Road, Rockford, Illinois (hereinafter the "Contractor") (the "County" and the "Contractor" are collectively known as the "Parties").

WHEREAS, the County and Contractor previously entered into an Agreement for Janitorial Services effective March 1, 2017 (hereinafter the "Agreement"), which provided for cleaning of numerous County locations two (2) days per week; and

WHEREAS, County desires to amend the Agreement to provide for janitorial services at certain County locations five (5) days per week rather than the originally contracted two (2) days per week; and

WHEREAS, Contractor has agreed to provide janitorial services five (5) days per week at the requested locations for an additional cost; and

WHEREAS, the Parties desire to amend the Agreement to provide for janitorial services at the following locations five (5) days per week: Wellness Center first floor area and the 5th floor Jury Commission room, 2nd floor Coroner's Office, and morgue basement location in the Public Safety Complex.

NOW, THEREFORE, in consideration of the foregoing premises, and other good and valuable consideration, the exchange, receipt, and adequacy of which the Parties hereby acknowledge, the Parties agree as follows:

- 1. County shall pay Contractor the following increased costs for janitorial services at the specified locations five (5) days per week instead of two (2) days per week:
 - a. An additional \$298.00 per month for the Wellness Center first floor area, for a total monthly cost of \$891.00; and
 - b. An additional \$982.00 per month for the 5th floor Jury Commission room, 2nd floor Coroner's Office, and morgue basement location, for a total monthly cost of \$11,298.00.
- 2. Contractor shall provide janitorial services, as set forth in the Specification List attached to the original Agreement, five (5) days per week at the Wellness Center first floor area and the 5th floor Jury Commission room, 2nd floor Coroner's Office, and morgue basement location in the Public Safety Complex.

- 3. All other terms and conditions contained in the Agreement, other than those specifically mentioned above, shall remain the same.
- 4. This Amendment shall bind and benefit both Parties and any successors or assigns.

WHEREAS, the County of Winnebago previously entered into an Agreement with Advanced Cleaning effective March 1, 2017, for janitorial services two (2) days per week at numerous County locations; and

WHEREAS, certain County locations, due to the nature of their operations, require janitorial services five (5) days per week; and

WHEREAS, Advanced Cleaning has agreed to provide janitorial services five (5) days per week for the Wellness Center first floor area and the 5th floor Jury Commission room, 2nd floor Coroner's Office, and morgue basement location in the Public Safety Complex for an additional cost; and

WHEREAS, the Operations Committee of the County Board for the County of Winnebago, Illinois, has reviewed and recommends approval of the proposed Amendment No. 1 to Agreement for Janitorial Services between Winnebago County, Illinois and Advanced Cleaning, as set forth in Exhibit A, attached hereto.

NOW THEREFORE BE IT AND IT IS HEREBY RESOLVED, by the County Board of the County of Winnebago, Illinois, that the Winnebago County Board Chairman is authorized to execute Amendment No. 1 to Agreement for Janitorial Services between Winnebago County, Illinois and Advanced Cleaning, in substantially the same form as that set forth in Exhibit A.
