#### Call to Order

#### **Public Comment**

Chairperson Salgado omitted reading the Public Comment Section of the Agenda due to no one present to speak.

## Feedback from Legislators - Discussion

Discussion took place on feedback from Legislators. Committee members shared information regarding Legislator feedback. Feedback has been positive from the Federal and State concerning the selection of the Federal lobbyist.

### State Lobbyist Interviews – Discussion

Discussion took place on State Lobbyist interviews and whether to reopen the bidding process for a State Lobbyist. Committee members shared their thoughts. The committee agreed to reopen the bidding process for a State Lobbyist. The RFQ will be reissued and those who previously submitted a proposal will be required to resubmit.

## **TFG Update - Discussion**

A meeting was held last week with the Mercury team and TFG to discuss the contract with plans for Mercury and TFG to meet to discuss coordination of grants, advocacy and other details. Internally, a discussion between Mercury, TFG and the County centered on coordination of the needs assessment, grant writing and lobbying. Committee members were given an overview of the process for submission and tracking of projects by department, agencies and non-county agencies. Projects will be prioritized with the focus on larger infrastructure grants. Initially, the focus is on the needs assessment. Processes are being developed that will flow from the needs assessment. TFG will develop a Strategic Funding Guide to be shared at a later date.

Discussion followed.

TFG will be contacted on the process for handling non-county partner requests. Chairperson Salgado called for any other questions, comments or thoughts.

## **Future Agenda Items**

- Mercury providing an updated Congressional Calendar.
- Next steps with Mercury from an appropriation standpoint in making connections with local, state and federal representatives to discuss County priorities and communication guidance.
- State Representative DeLuca asked if the committee would consider drafting a letter
  of support for the Solar Farm bill and talk with legislators to co-sponsor the bill. A
  synopsis of the bill will be provided to committee members.

- A meeting is scheduled in November to tour landfill operations in Broward County, Florida that converts waste to energy and meet with the County Chairman of Broward County, Florida.
- Mercury was engaged to reach out to the Federal Department of Energy to ask why
  the interconnect and capacity issues are stifling growth in Winnebago County. A letter
  was sent to Mr. Quinionas, Chairman of ComEd requesting a meeting to discuss green
  energy initiatives and incentives.
