

The Term of the License is for one year commencing on November 1, 2025 ("Commencement Date") and ending on October 31, 2026 ("Expiration Date"), at which time the Agreement will automatically renew for successive periods of one (1) year each commencing on the anniversary of the Commencement Date (each, a "Renewal Term") unless either Party provides the other with written notice of non-renewal at least ninety (90) days prior to the expiration of the thencurrent Term.

The terms of the Agreement are covered by this Agreement, the Terms and Conditions and Schedule A (Pricing) attached hereto, all of which constitute the complete and exclusive agreement between the Parties with respect to the subject matter hereof, and supersede and replace any and all prior or contemporaneous discussions, negotiations, understandings and agreements, whether written and oral, regarding such subject matter, including any previously executed agreements between the Parties unless amended in a writing executed by both Parties.

#### **TERMS AND CONDITIONS**

- Subscription License Grant. Subject to the terms of this Agreement, ForceMetrics grants to Customer and its officers, employees and consultants so authorized by Customer (individual, as "User" and collectively as "Users") a non-exclusive, non-transferable, royalty-free, limited term subscription-based license to access and use ForceMetrics' web-based application software providing law enforcement entities unified search capabilities, visualizations of public safety data, and data linkage from multiple existing data sources related to community impact, operational efficiencies, and performance metrics in order to identify community needs, measure success and mitigate risks ("Software Solution") from Customer devices, including Customerowned and issued desktop computers, laptops, tablets, mobile devices and the like, in connection with the performance of their job duties and within the parameters set with respect thereto. Access to and use of the Software Solution shall include, where applicable, Customer's right to use ForceMetrics' application programming interfaces ("API") to connect to the ForceMetrics' platform ("Platform") through which a User may obtain access to the Software Solution.
- 2. Platform Access. ForceMetrics will be responsible for hosting the Platform, and any API necessary for access to the Platform. Customer and authorized Users will be responsible for obtaining internet connections and other third-party software, hardware and services necessary to access such Platform through the internet as set forth in ForceMetrics' Technical Requirements Technical Requirements and Support
- 3. Standard Support Services. ForceMetrics offers Standard Support Services in connection with the Agreement as further described in Section 13 of these Terms and Conditions and as set forth in Technical Requirements and Support The Software Solution, API, Platform and supporting Standard Support Services may be collectively referred to herein as "Service."
- 4. Custom Professional Services. To the extent any Customer requests modifications to the Service requiring development of any customization or configuration to the Software Solution, API or Platform ("Custom Professional Services"), such Custom Professional Services shall be set forth in a separate agreement or a signed addendum hereto, and intellectual property rights in such Custom Professional Services shall be owned by ForceMetrics.
- **5.** Access/Credentials. Customer will ensure that each User creates and keeps strictly confidential a unique user ID and password for access to the Service, and Customer will remain responsible for any and all actions taken using Customer's account.

Customer hereby grants to ForceMetrics a non-exclusive, worldwide, royalty-free right to use, copy, store, transmit, modify, create derivative works of and publicly perform and display the Customer Data in connection with providing the Service hereunder and as set forth in Section 21 below. To the extent that Customer Data is public data, i.e. data that would be releasable pursuant to a request under the Freedom of information Act or the relevant state public records law ("Public Data"), Customer grants to ForceMetrics the right to use, reproduce, store and distribute (including the right to permit third parties to use, reproduce, store and distribute) Public Data for any purpose, including sharing with known law enforcement or criminal justice personnel in the pursuit of law enforcement or criminal justice goals.
- Customer Obligations. Customer will ensure Users' use of the Service and Customer Data is at all times compliant with Customer's privacy policies and applicable laws, regulations and conventions applicable thereto, including, without limitation, those related to privacy, data security and the handling of Personal Data. Customer is solely responsible for the accuracy, content and legality of Customer Data. ForceMetrics will ensure that the Service and use or processing of Customer Data is at all times compliant with ForceMetrics' privacy policy <a href="https://www.forcemetrics.com/privacy-policy">https://www.forcemetrics.com/privacy-policy</a>, and applicable laws, regulations and conventions applicable thereto, including, without limitation, those related to privacy, data security and the handling of Personal Data.
- Term and Termination. The "Term" of this Agreement shall 11. be as set forth on Page 1 of this Agreement. Should this Agreement not be renewed or otherwise be terminated, each Party will return or destroy the other Party's Confidential Information, and ForceMetrics shall immediately disable and/or terminate Customer's access to the Service and Customer shall delete from all devices the Software Solution. - 12. Payment Terms. Customer will pay ForceMetrics as set forth in Schedule A. Payments will be due on or before the date due with notice or demand, and payment must be made in US Dollars. Taxes might apply. Sales tax and import duties are not included. State and local taxes may apply unless a valid exemption certificate is on file or submitted at the time of order. - **13. # 14. Software Solution Content; Machine Learning (AI/Generative AI).

- a. Data from External Data Sources. Customer understands and acknowledges that the Software Solution provides search capabilities, visualizations of public safety data, private and public data sources, and data linkage from multiple existing data sources related to community impact, operational efficiencies, and performance metrics in order to identify community needs, measure success and mitigate risks, and ForceMetrics does not investigate, qualify or verify the accuracy of any such information and in no case will be liable for the same.
- b. Machine Learning. As permitted by applicable law, the Software Solution may utilize non-generative and generative AI to process and create probabilistic outputs and predictions based on existing data, including natural language processing to create officer/community labels, text summarizations, topic modeling, and sequential pattern analysis. ForceMetrics reserves the right, in its sole discretion to incorporate additional machine learning processes, including but not limited to named entity extraction, sentiment analysis, speech recognition, text clustering, ontology mapping, labeling accuracy, and other techniques. Customer acknowledges that AI information, predictions or probabilities are not guaranteed to be accurate or complete, and that Customer should not rely solely on the Software Solution content for critical decision making.
- c. **Text/Narrative Summaries.** Text summarizations ("Narrative Summaries") within the Software Solution are automatically generated excerpts of full reports, are not comprehensive and are not guaranteed to be accurate. User acknowledges that such Narrative Summaries may omit certain information or be open to interpretation due to information that is included or not included therein. Narrative Summaries are "AS IS" without any assurances of completeness, accuracy, usefulness, or timeliness, and without any explicit or implied warranties. It is crucial that User not make public safety decisions, take actions or fail to take actions based solely on Narrative Summaries.
- 15. Software Solution Updates. ForceMetrics may, at any time and in its sole discretion, without prior warning or notice, modify, update, add or remove features and functionality of the Software Solution or suspend and/or cease providing the Software Solution or any part of the Software Solution. The Software Solution may communicate with ForceMetrics' servers from time to time to check for available updates, such as bug fixes, patches, enhanced functions, missing plug-ins and new versions (collectively, "Software Updates"). Such Software Updates may be in various forms and are generally provided for the purposes of improving the performance, security and reliability of the Software Solution. Customers are required to accept and install all Software Updates and upgrades.

- 16. Ownership of Software Solution. Customer acknowledges they are obtaining only a limited right to the Software Solution and that no ownership rights or extended usage rights are granted to Customer under this Agreement. ForceMetrics retains all right, title and interest (including all patent, copyright, trademark, trade secret and other intellectual property rights) in and to the Software Solution, to any and all related and underlying technology and documentation for the Software Solution, and to any derivative works, modifications or improvements of any of the foregoing, specifically including any feedback from Customer ("ForceMetrics Technology"). Except as expressly set forth in the Terms and Conditions, no right, title or interest in any ForceMetrics Technology is granted to Customer.
- Confidential Information. Customer and ForceMetrics may disclose to each other information regarding their respective businesses and technologies which information is either identified at the time of disclosure as confidential or which should be reasonably known by the receiving Party to be confidential ("Confidential Information"). The Service is Confidential Information of ForceMetrics and all Customer Data is Confidential Information of Customer. Except as specified otherwise herein, the receiving Party will (i) hold in confidence and not disclose any Confidential Information to third parties and (ii) not use Confidential Information for any purpose other than fulfilling its obligations and exercising its rights under this Agreement. The receiving Party may disclose Confidential Information to its employees, agents, contractors and other representatives having a need to know, provided that such representatives are bound to confidentiality obligations no less protective of the disclosing Party than this Section 17 and that the receiving Party remains responsible for compliance by any such representative with the terms of this Section 17. These restrictions on disclosure will not apply to any information which: (a) is or becomes generally known or publicly available through no act or omission of the receiving Party; (b) is known by the receiving Party without confidentiality restriction at the time of receiving such information, as shown by written records; or (c) is furnished to the receiving Party by a third party without confidentiality restriction. The receiving Party may make disclosures to the extent required by law or court order, provided the receiving party notifies the disclosing party in advance and cooperates in any effort to obtain confidential treatment. The receiving party acknowledges that disclosure of Confidential Information would cause substantial harm for which damages alone would not be a sufficient remedy, and therefore that upon any such disclosure by the receiving party the disclosing Party will be entitled to seek appropriate equitable relief in addition to whatever other remedies it might have at law.
- Data Security and Processing. ForceMetrics will maintain administrative, physical, and technical safeguards designed to protect the security and confidentiality of Customer Data, including measures designed to prevent unauthorized access, use, modification, or disclosure of Personal Data. ForceMetrics and Customer agree to operate in conformance with the physical, technical, operational, and administrative measures and protocols regarding data security for the Service as set forth in the Security Policy. - **20. Feedback; Service Data.** From time-to-time during the Term, ForceMetrics may request from or receive from Customer, such as in surveys, comments, questions, suggestions or other feedback relating to the Service or otherwise to ForceMetrics' products and services ("Feedback"). ForceMetrics may freely use or exploit Feedback in connection with the Service as well as any of its other current or future-developed products or services.
- Derived Data. Customer acknowledges and agrees that ForceMetrics shall have the right to utilize data capture, syndication, and analysis tools, and other similar tools, to extract, compile, synthesize, and analyze any Customer Data, including configurations, categorization and classification of data, log data, performance results and Personal Data, resulting from Customer's use of the Service ("Derived Data"). Derived Data, as used herein, shall also mean any information or data of any kind which has been created or derived by ForceMetrics during the scope of providing Services which is the result, directly or indirectly, from the manipulation, derivation, calculation or analysis of Customer Data (whether generated by human or machine) whether alone or in conjunction with other data such that (i) Customer Data cannot be identified by visual inspection, extracted or reverse engineered from it, (ii) it is substantially different from and does not resemble Customer Data, unless any resemblance is purely coincidental following a bona fide and demonstrable derivation process, (iii) it has been de-identified, aggregated or anonymized such that it includes no Personal Data, (iv) it is used for security and operations management, to create statistical analyses, for research and development purposes and incorporated into aggregated and anonymized data sets for the purpose of improving and commercializing products, software, technology and services of ForceMetrics. - 23. No Warranty. THE SERVICE IS PROVIDED "AS IS" AND FORCEMETRICS MAKES NO WARRANTIES, EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY, TITLE, FITNESS FOR A PARTICULAR PURPOSE OR NONINFRINGEMENT. FORCEMETRICS DOES NOT WARRANT THAT CUSTOMER'S USE OF THE SERVICE WILL BE UNINTERRUPTED OR ERROR-FREE, NOR DOES FORCEMETRICS WARRANT THAT IT WILL REVIEW THE CUSTOMER DATA FOR ACCURACY OR THAT IT WILL PRESERVE OR MAINTAIN THE CUSTOMER DATA WITHOUT LOSS. FORCEMETRICS SHALL NOT BE LIABLE FOR DELAYS, INTERRUPTIONS, SERVICE FAILURES OR OTHER PROBLEMS INHERENT IN USE OF THE INTERNET AND ELECTRONIC COMMUNICATIONS OR OTHER SYSTEMS OUTSIDE OF FORCEMETRICS' REASONABLE CONTROL. CUSTOMER MAY HAVE OTHER STATUTORY RIGHTS.
- 24. Limitation of Liability. EXCEPT FOR EXCLUDED CLAIMS, (A) IN NO EVENT SHALL EITHER PARTY BE LIABLE FOR ANY LOSS OF USE, LOST OR INACCURATE DATA, FAILURE OF SECURITY MECHANISMS, INTERRUPTION OF BUSINESS, OR ANY INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES OF ANY KIND (INCLUDING LOST PROFITS), REGARDLESS OF THE FORM OF ACTION, WHETHER IN CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR OTHERWISE, EVEN IF INFORMED OF THE POSSIBILITY OF SUCH DAMAGES IN ADVANCE; AND (B) NOTWITHSTANDING ANY OTHER PROVISION OF THIS AGREEMENT, EACH PARTY'S ENTIRE LIABILITY TO THE OTHER PARTY UNDER THIS AGREEMENT SHALL NOT EXCEED THE GREATER OF (I) THE AMOUNT ACTUALLY PAID BY CUSTOMER TO FORCEMETRICS UNDER THIS AGREEMENT OR (II) TEN THOUSAND DOLLARS (USD \$10,000). "Excluded Claim" means any claim arising (a) from Customer's breach of Section 1 (Subscription License Grant) or Section 6 (General Restrictions). (b) under Section 9 (Customer Obligations), or (c) from a Party's breach of its obligations in Section 17 (Confidential Information). FORCEMETRICS' LIABILITY FOR DAMAGES ARISING FROM A BREACH OF THE OBLIGATIONS OF CONFIDENTIALITY IN SECTION 17 OF THIS AGREEMENT SHALL NOT EXCEED TWO THOUSAND DOLLARS (\$50,000 USD) PER CLAIM.

## 25. Indemnification and Insurance.

a. Indemnification by ForceMetrics. ForceMetrics will defend, indemnify and hold harmless Customer and its Users, and each of their elected and appointed officials, officers, directors, managers, shareholders, attorneys, members and employees from any and all claims, liabilities, costs and expenses (including reasonable attorney fees) in connection with any third party claim arising from or related to allegations that use of the Software Solution in accordance with this Agreement infringes or misappropriates the intellectual property rights of such third party; provided however, that the foregoing obligations shall be subject to Customer (1) promptly notifying ForceMetrics of the claim, (2) and providing ForceMetrics with reasonable cooperation in defense of such claim. Notwithstanding the foregoing, ForceMetrics

shall have no obligation with respect to a third party claim to the extent such claim arises from (i) acts of omissions of Customer or its affiliates, Users, employees or contractors, (ii) claims brought by Customer or its affiliates or Users, (iii) use of old versions of the Software Solution after notice and receipt of modified or updated software or the like, (iv) use of third party applications, components or data, (v) data, products, information or materials provided by Customer or a third party, (v) use of the Software Solution in connection with modules, apparatus, hardware, software or other services not authorized by ForceMetrics or specified for use with the Software Solution by ForceMetrics, (vi) use of the Software Solution in any way not authorized or specified by ForceMetrics, or (vii) alteration or modification of the Software Solution by a party other than ForceMetrics. If the Software Solution is (or ForceMetrics believes is likely to become) the subject of a claim for which ForceMetrics would be obligated to defend and indemnify pursuant to this Section 25, the ForceMetrics may, at its sole option: (A) obtain for Customer the right to continue use of the Software Solution; (B) provide a substitute platform to Customer provided there is no material loss of functionality.; or (C) terminate this Agreement.

- **c. Insurance.** ForceMetrics shall maintain insurance coverages as follows written by companies with an A.M. Best rating of at least B+/A-.
- 1. Commercial General Liability insurance, with minimum combined single limits of \$1,000,000 per-occurrence, \$1,000,000 Products/Completed Operations Aggregate and \$1,000,000 general aggregate. Coverage must be written on an occurrence form.
- 2. Workers' Compensation insurance with statutory limits; and Employers' Liability coverage with minimum limits for bodily injury: a) by accident, \$100,000 each accident, b) by disease, \$100,000 per employee with a per policy aggregate of \$500,000.
- 3. Business Automobile Liability insurance covering owned, hired and non-owned vehicles, with a minimum combined bodily injury and property damage limit of \$1,000,000 per occurrence.
- 4. Professional Liability (Directors and Officers Liability) and Cyber Risk Insurance (including technology and media errors and omissions, privacy and network security), covering acts, errors, and omissions arising out of ForceMetrics' operations or services with minimum limits of \$1,000,000 per occurrence, \$1,000,000 annual aggregate.
- 25. Export Control. In performance of this Agreement, Customer and ForceMetrics each agree to comply with all export and import laws and regulations of the United States and other applicable jurisdictions. Without limiting the foregoing, (a) Customer and ForceMetrics each represents and warrants that it is not listed on any U.S. government list of prohibited or restricted parties or located in (or a national of) a country that is subject to a U.S. government embargo or that has been designated by the U.S. government as a "terrorist supporting" country, (b) Customer will not (and will not permit any of its users to) access or use the Service in violation of any U.S. export embargo, prohibition or restriction, and (c) Customer will not submit to the Service any information that is controlled or prohibited under any U.S. trade regulations.
- **26. General.** This Agreement will be governed by and construed under the laws of the State of Illinois. Any suit or proceeding arising out of or relating to this Agreement will be commenced exclusively in the state or federal courts in Winnebago County, Illinois and each Party irrevocably submits to the exclusive jurisdiction and venue of such

courts. The United Nations Convention on Contracts for the International Sale of Goods is specifically disclaimed. The parties are independent contractors and no employment, agency, or joint venture is created hereunder. All notices, requests and other communications under this Agreement must be in writing, and must be mailed by (a) registered or certified mail, postage prepaid and return receipt requested, (b) nationally recognized delivery or courier service with tracking service, or(c) delivered by hand to the party to whom such notice is required or permitted to be given, at the addresses of the Parties set forth below (or such other addresses as the parties may designate from time to time by like notice): ForceMetrics, 2590 Welton Street, Suite 200, Denver, Colorado 80205; County of Winnebago, Illinois, 404 Elm Street, Rockford, Illinois 61101 and Winnebago County Sheriff's Office, Winnebago County Justice Center, 650 W. State Street, Rockford, IL 61101. ForceMetrics will not be responsible for any delay or failure to perform any obligations to Customer which is caused by any Force Majeure event or other action beyond a Party's control. "Force Majeure" will include but not be limited to: acts of nature, floods or fire; transportation, power or other supply shortages or unavailability, failure or delays; strikes or labor shortages; government actions, orders or restrictions; disease or pandemic; and wars, insurrections, or acts of terrorism. If the Force Majeure event continues for a period of time that makes performance hereunder impossible or impracticable, either Party may terminate the Agreement upon thirty (30) days' written notice to the other Party. All amendments must be in writing and signed by both parties. Waivers must be in writing and no waivers will be implied. Customer may not assign or amend this Agreement without the prior written consent of ForceMetrics, and any purported assignment or amendment in violation of the foregoing will be void. # RESOLUTION TO SUBMIT AN ADVISORY REFERENDUM TO THE VOTERS OF WINNEBAGO COUNTY, ILLINOIS REGARDING THE FEDERAL SCHOLARSHIP TAX CREDIT

WHEREAS, the County of Winnebago, Illinois is a duly organized and existing county created and operating under the provisions of the Illinois Counties Code and the laws of the State of Illinois; and

**WHEREAS**, the Illinois Election Code provides that any public question authorized by statute shall be initiated in accordance with 10 ILCS 5/28-1 and 5/28-5; and

WHEREAS, Section 5-1005.5 of the Counties Code, 55 ILCS 5/5-1005.5, provides that, by a vote of a majority of the county board, the county board may authorize that an advisory question of public policy be placed on the ballot at the next regularly scheduled election in the county; and

WHEREAS, the Educational Choice for Children Act offers a federal tax credit of up to \$1,700 for individuals that donate to Scholarship Granting Organizations, thereby increasing funding for these organizations to help families pay for their children to attend the K-12 school of their choice; and

WHEREAS, if Illinois opts in, scholarship funds could be used by students in both public and private schools for a multitude of educational services, including tutoring, additional educational classes, books or online educational materials, educational therapies for students with disabilities, fees for standardized or college admission exams and fees for dual enrollment; and

WHEREAS, donors to scholarships will benefit from tax credits regardless of whether Illinois opts in, but Illinois students will not receive those funds unless the state opts in; and

WHEREAS, opting into the program would not take money away from public schools, nor would it divert federal money or state money from public schools to fund the scholarships; and

WHEREAS, the County Board of the County of Winnebago, Illinois finds it to be in the best interests of Winnebago County, Illinois to put a non-binding, advisory referendum question on the ballot regarding whether the state of Illinois should opt into the scholarship program created by Educational Choice for Children Act, and that said question should be submitted by referendum to the Winnebago County, Illinois electorate at the March 17, 2026 general primary election.

Should Illinois opt into a federal program that would provide Public K-12, private school, and homeschool students with privately-donated funds for academic needs, such as tutoring and test preparation, educational therapies for students with disabilities, tuition, books, exam fees or for other specified academic needs?

A request has been filed with the Winnebago County Community Development Department's Planning & Zoning Division for a Resolution granting site approval of a 10 MW commercial solar energy facility (AKA Solar Farm) on a 140.43 acre site for property located at 8616 Spring Creek Road. This property is bounded by Spring Brook on the north, Lyford Road on the east, Spring Creek Road on the south and Interstate 90 on the west. The property currently has agricultural crops.

State of Illinois Public Act (P.A.) 102-1123, an energy omnibus law, establishes uniform standards for the development and construction of commercial wind and solar energy facilities, limiting County authority to be no more restrictive than the provisions of the Act. The City of Rockford has been very supportive of solar energy projects but they have to be located in suitable locations that do not inhibit the growth of the City. This is a highly visible site along I-90 that is prime for growth and development.

The City's long range 2040 Plan designates the area as T-C-CO, Technology-Retail-Office along I-90 and RM, Medium Density Residential along the border of Lyford Road. A solar farm would not be compatible with the planned future uses. The property is adjacent to the City's municipal boundaries on the north and west. City Water is available as major 20-inch water main runs along the northern boundary of the subject property within the Spring Brook Road right-of-way and the Keith Creek Sewer Trunk line runs directly through this property along Keith Creek. In addition, the City provided \$15 million in new roads to the north of this site in anticipation of more growth for the area. These major capital investments have provided the necessary infrastructure needed to facilitate orderly growth in this area as evidenced by the MercyHealth Hospital Development adjacent to this site.


The City has made great strides in controlling future growth along the east side of I-90 and we continue to hold to the policies of the Comprehensive plan and our Annexation policy. Additionally, the Lyford Road corridor plan would map out the future reconstruction and potential realignment of the road from Spring Brook Road to East State Street. A solar farm in this location could stifle growth and inhibit our ability to facilitate orderly growth of the City. Therefore, we recommend that the Committee forward a recommendation to City Council to file as a legal objector to this zoning request.

**Governing Code/s:** Winnebago County Code, Chapter 90 (UDO), Article 17: Commercial Wind Energy Facilities and Commercial Solar Energy Facilities, as amended on July 25, 2024.

Review Comments: The Winnebago County Board approved the above noted County Ordinance (that limits the County's ability to self-regulate) on July 25, 2024, as mandated by a State Law amendment made on January 27, 2023 to the Illinois Counties Code, 55 ILCS 5/5-12020. As a result, this new County Ordinance now governs the siting of commercial solar energy facilities (aka a solar farm) in Winnebago County, Illinois, consequently, requiring the County Board to review all applications for "siting approval" with regard to Commercial Solar Energy Facilities when on property that is zoned industrial as well as AG, A1 and A2. The Ordinance further provides that a request for site approval shall be approved, after consideration of the evidence (presented at a public hearing) and verbatim transcript of hearing, if the request is found to be in compliance with the standards and conditions outlined within the County's Ordinance (that was adopted consistent with 55/ILCS 5/5-12020) as well as any other conditions imposed under State and Federal statutes and regulations. Accordingly, the Applicant is requesting site approval, but not without a public hearing 1st being held before the ZBA, of the attached 10 MW solar project/submittal (which appears to have conceptually satisfied -subject to the specific terms and stipulations drafted, and provided nothing new is presented at the public hearing that would prove otherwise- all of the requisite standards and conditions delineated by County Ordinance / Statue) on a 140.43 +- acre site, zoned AG, which is commonly known as 8016 Spring Creek Road (PINS: 12-11-226-001 & 12-12-101-003), Rockford, IL 61114, in Rockford Township.

However, and although the reviewing bodies should adhere to the standards and conditions set forth under 55 ILCS 5/5-12020 and the County's Ordinance, as noted above, in the evaluation and decision of this solar request, it would be remise (negligent) of the Planning Staff to not provide background information and comment with regard to the County's 2030 Land Resource Management Plan – Future Land Use Map policy as it relates to the subject property, especially due to the size of the property / proposed solar project (largest solar project processed to date in the County), its proximity to the City of Rockford and it being within a highly active growth corridor. Accordingly, the subject property is within the City of Rockford's extra-territorial review authority – planned growth area, and in the spirit of regional cooperation – and consistent with Plan policy, the Applicant was encouraged to annex the site (and develop the subject property under Rockford's lead), but the Applicant declined and decided to continue with their case in the County. This decision prompted concern among Staff due to the above noted and the fact that the City of Rockford -in addition to the single largest private sector investment ever made



within Rockford limits (to the north)- has invested heavily with regard to the area by creating and adopting land use plans (to guide future growth) and installing public infrastructure (i.e. public water, road improvements, etc. - see map attached), primarily to the north, to enable development / economic opportunities that can take advantage of said, including the accessibility (or visibility) offered by surrounding and nearby arterial roads (i.e. I-90, Spring Creek Road, Lyford Road, Riverside Road and Spring Brook Road). The proposed solar project does not need the accessibility (or visibility) offered by the nearby roads, will not utilize existing infrastructure improvements nor has it been designed (located) in a manner that best promotes other development opportunities that will assist in lowering the tax burden upon residents - consistent with Plan policy.

In the end, after informing the Applicant of the above noted Plan policy, etc., and when it was clear that they were not going to change course with regard to their solar site approval approach (a City rather than a County submittal), Staff then provided further comment (concern) with regard to leaving the subject property zoned agricultural in the County, as this will effectively "leave the door open" for a wall / island / pocket of AG to be left within a sea of anticipated industrial, commercial and or residential zonings that could cause incompatibility / growth (obstacle) issues in the future. To prevent this scenario, Staff encouraged the Applicant to rezone the subject property consistent with the 2030 Future Land Use Plan Map, and redesign (relocate) the solar project on the site in a manner that best promotes other development on the site that is consistent with the Plan, including leaving the area fronting roadways available for future uses (i.e. commercial, industrial, etc.) that can best benefit from the adjacent roads and the high visibility offered by them. As of the date of this executive summary, none of the above said planning policy suggestions were incorporated within the current solar request / design (see the attached Site Plan and 2030 Future Land Use Plan Map).

Recommendation/s: The Zoning Board of Appeals should make a recommendation for the County Board's consideration of the hereto attached Ordinance (site approval request) in accordance with the requisite standards and conditions (criteria) set forth by the County's Ordinance (that was adopted consistent with 55/ILCS 5/5-12020) as well as any other conditions imposed under State and Federal statutes and regulations. The Zoning Committee should also make a recommendation after consideration of the criteria noted above, however, per Section 17.3 A. the Committee may also give due consideration of the public testimony (from the public hearing), and in doing so, may consider the factors set forth in Article 4, Section 4.3.4(4)(a-f) Findings of Fact when making their recommendation. After considering both recommendations, based on the applicable codes (criteria) noted above, the County Board shall ultimately approve or deny the Ordinance (site approval request) for the proposed commercial solar energy facility at the 140.43 +- acre site that is commonly known as 8016 Spring Creek Road (PINS: 12-11-226-001 & 12-12-101-003), Rockford, IL 61114, in Rockford Township.

ORDINANCE GRANTING SITE APPROVAL FOR A 10 MW COMMERCIAL SOLAR ENERGY FACILITY (AKA A SOLAR FARM) ON A 140.43 +- ACRE SITE COMMONLY KNOWN AS 8016 SPRING CREEK ROAD (PINS: 12-11-226-001 & 12-12-101-003), ROCKFORD, IL 61114, IN ROCKFORD TOWNSHIP

WHEREAS, Rockford Brook A, LLC and Rockford Brook B, LLC – which are managed by TotalEnergies Distributed Generation Assets USA, LLC and are indirect subsidiaries of TotalEnergies Distributed Generation USA, LLC (hereinafter "the Facility Owner"), formally filed an application for site approval to operate a 10 MW commercial solar energy facility (hereinafter "the Facility") within unincorporated Winnebago County, Illinois on a 140.43 +- acre site, zoned AG, Agricultural Priority District, that is commonly known as 8016 Spring Creek Road (PINS: 12-11-226-001 & 12-12-101-003), Rockford, IL 61114 in Rockford Township (hereinafter "the Property") and specifically legal described as:

Picken by Warranty Deed dated August 31, 1956 and recorded in Book 1016 of Deeds on Page 474 in said Recorder's Office (the last three previously described courses being along the East and North lines of said permanent easement); thence North 00 degrees 21' 34" East, along the East line of said premises so conveyed to Illinois State Toll Highway Commission, 1272.52 feet to a point which bears South 88 degrees 54' 50" West, from the point of beginning; thence North 88 degrees 54' 50" East, parallel with the South line of the Northwest Quarter (1/4) of said Section 12 a distance of 1190.36 feet to the point of beginning; situated in the County of Winnebago and State of Illinois; and Tract E: Part of the Northwest Quarter (1/4) of Section 12 and part of the Northeast Quarter (1/4) of Section 11, all in Township 44 North, Range 2 East of the Third (3rd) Principal Meridian, bounded and described as follows, to-wit: Beginning at a point in the North line of the Northwest Quarter (1/4) of said Section 12 which bears South 89 degrees 03' 39" West, 1170.5 feet from the Northeast corner of the West Half (1/2) of the Northwest Quarter (1/4) of said Section 12; thence South 00 degrees 33' 23" West, parallel with the East line of the West Half (1/2) of the Northwest Quarter (1/4) of said Section 12 a distance of 1318.00 feet; thence South 88 degrees 54' 50" West, parallel with the South line of the Northwest Quarter (1/4) of said Section 12 a distance of 1190.36 feet to the East line of premises conveyed by George C. Picken to Illinois State Toll Highway Commission by Warranty Deed dated August 31, 1956 and recorded in Book 1016 of Deeds on Page 474 in the Recorder's Office of Winnebago County, Illinois; thence North 00 degrees 21' 34" East, along the East line of said premises so conveyed to Illinois State Toll Highway Commission, 1311.21 feet to the North line of the Northeast Quarter (1/4) of said Section 11; thence North 88 degrees 31' 16" East, along the North line of the Northeast Quarter (1/4) of said Section 11 a distance of 1032.82 feet to the Northeast corner of the Northeast Quarter (1/4) of said Section 11; thence North 89 degrees 03' 39" East, along the North line of the Northwest Quarter (1/4) of said Section 12 a distance of 162.27 feet to the point of beginning: situated in the County of Winnebago and State of Illinois.

WHEREAS, Illinois Counties Code, specifically 55 ILCS 5/5-12020 (hereinafter "the Statute"), effective January 27, 2023, governs the requirements for the siting of commercial solar energy facilities in the State of Illinois and prohibits counties from enacting more restrictive requirements in regard to said facilities than those set forth in the Statute. Consequently, the County may not adopt zoning regulations that disallow, permanently or temporarily, commercial solar energy facilities from being developed or operated in any district zoned to allow agricultural or industrial uses; and

WHEREAS, the County of Winnebago, Illinois (hereinafter "County") has amended its Unified Development Ordinance, Chapter 90, of the Winnebago County Code (hereinafter

"UDO"), to be in accord with the Statute, and thus, the commercial solar energy facility site approval application that was submitted for the Property was reviewed in accordance with said UDO; and

WHEREAS, the UDO provides that a request for siting approval for a commercial solar energy facility, "shall be approved if the request is in compliance with the standards and conditions imposed in 55 ILCS 5/5-12020, the zoning ordinance adopted consistent with 55 ILCS 5/5-12020, and the conditions imposed under State and Federal statutes and regulations"; and

WHEREAS, upon review of the application, the Facility Owner (Facility) has conceptually satisfied all of the requisite standards and conditions under the UDO, however, that, in the event a detail or representation in the application conflicts with the UDO, Statute or any other applicable Illinois law or regulation, the conflicting provision shall prevail and the Facility Owner shall adhere thereto and adjust the contradiction, as will be required, at time of construction permit submittal; and

WHEREAS, a public hearing was held on the site approval request before the Zoning Board of Appeals (ZBA) on October 8, 2025 and the ZBA recommended denial (2-5); and

WHEREAS, the Zoning Committee of the County Board of the County of Winnebago, Illinois considered the ZBA's recommendation (motion) as well as the evidence submitted (at the public hearing) as it relates to the standards and conditions outlined within the UDO, and consequently, the Zoning Committee recommended approval (3-2) of the Facility Owner's site approval request to install and operate a commercial solar energy facility on the Property.

NOW, THEREFORE BE IT ORDAINED that the County Board of the County of Winnebago, Illinois -after the consideration of the above noted recommendations, the standards and conditions outlined within the UDO and being fully advised on all other matters affiliated to the Property (request)- hereby grants the Facility Owner's site approval request to install and operate a 10 MW or less commercial solar energy facility on the 140.43 +- acre site, zoned AG,

Agricultural Priority District, that is commonly known as 8016 Spring Creek Road (PINS: 12-11-226-001 & 12-12-101-003), Rockford, IL 61114 in Rockford Township and specifically described in "1<sup>st</sup> Whereas", subject to the following terms and stipulations:

- 1. The commercial solar energy facility (the Facility) shall be developed in substantial conformance with the Array Layout Plan, revision 09-16-25, sheet AL1, and submitted by TotalEnergies, inclusive of the notes thereon Plan. In no event shall the final design of the solar energy facility consist of above ground (overhead) power and transmission lines.
- 2. Lighting of a permanent nature shall not be included within the development (the Facility), unless required by law. Lighting for safety/security purposes, however, when triggered on by a motion detector, is permissible (since lighting will only be on, on a non-permanent basis, if ever).
- 3. Fencing around the Facility shall be of a suitable habitat wildlife friendly type, not inclusive of barbed wire nor higher than seven (7) feet, and consist of a 6-inch gap along the bottom to prevent the restriction of wildlife movement.
- 4. The Facility Owner (Rockford Brook A, LLC and Rockford Brook B, LLC) shall strictly adhere to all the terms and conditions of the signed Agricultural Impact Mitigation Agreements with the Illinois Department of Agriculture, dated (signed on) May 27, 2025 and July 2, 2025 and as may be amended, including, but not limited to, any terms and conditions that are not specifically referenced or set forth in this Ordinance.
- 5. The Facility Owner shall submit a final vegetative management plan (that consists of, but not limited to, a plan to prevent the spread of invasive species throughout the lifetime of the project), including a final landscape / screening plan (consistent with the guidelines adopted by IDNR for such plans as well as the AIMA), for approval at time of construction

permit submittal -pursuant to Section 17.4 D. 11. of UDO- that consists mostly of a vegetative pollinator-friendly ground cover, where practical (i.e. a wetland type ground cover may instead be better suited for a periodically wet detention basin), that is in substantial conformance with the site plan (noted in stipulation number 1) and is in accordance with (and the goals of) the Pollinator-friendly Solar Site Act. Moreover, the same final plan/s shall include the vegetative screening demarked on said site plan which shall be comprised of 6-foot evergreens or greater, no less than two species, at time of planting, that are spaced in a manner that is intended to provide a full (100%) screening with an ultimate height that is no less than the height of the solar panel's height at full tiltat time of tree maturity. And lastly, the natural perimeter screening when located on the Property, shall be maintained (not removed), with the exception of a substantiated necessary utility connection that cannot be routed elsewhere.

- 6. The Facility Owner shall submit a final road use (route plan/transportation plan/traffic safety plan/use of public roads plan) agreement for approval at time of construction permit submittal -pursuant to Section 17.5.7 of UDO- with the County, and any other applicable unit of government such as the Township and or Illinois Department of Transportation.
- 7. The Facility Owner shall submit a final drainage plan and or stormwater BMP, as determined by County Engineer, for approval at time of construction permit submittal -pursuant to Sections 17.4 D. 12. and 17.5.13 of UDO- with the County.
- 8. The Facility Owner shall obtain all required permits and approvals prior to taking any construction action, including, but not limited to a building permit, a zoning clearance/permit, a site access permit, Winnebago County Surface Water Management Ordinance (WC-SWMO) permits / stormwater plan approvals (i.e. with regard to

- detention, Stormwater Pollution Prevention Plan (SWPPP), and NPDES Construction General Permit), and the approval of an erosion sediment and control plan.
- 9. During construction, the Facility Owner shall use their best efforts to limit soil compaction (by reducing trips across the subject area, by working with or on soils when dry, by reducing pressure of the equipment and by maintaining organic matter within the soil) and shall prevent soil contamination from the components that are imbedded within the panels, especially any damaged panels (by storing all solar panels within an enclosed structure and or on and under a tarp). Likewise, in the event there are compacted soils onsite, subject soils shall be de-compacted prior to planting of groundcover plantings.
- 10. The Facility Owner shall provide the County with a final deconstruction / decommissioning Plan (estimate), for approval prior to final construction (building) inspection -pursuant to Sections 17.4 D.5. and 17.11 of UDO (based on the construction plans ultimately approved at time of construction permitting)- by an Illinois licensed professional engineer, inclusive of financial assurance, in the form of an irrevocable letter of credit or another form of available financial assurance acceptable to the County, to cover the estimated costs of deconstruction of the Facility (see stipulation number 14 proposed by the Facility Owner for additional details with regard to the financial assurance to deconstruct / decommission the Facility). The County shall be the designated beneficiary of the financial surety, and the landowner shall be provided with a copy of the document. In the event of abandonment, the County may take all appropriate actions for deconstruction including drawing upon the financial assurance.
- 11. Prior to the issuance of building and zoning permits, the Facility Owner shall obtain clearance (consultation be terminated) from the IDNR, Illinois State Historic Office, with

- regard to the solar development's (the Facility's) potential effect on cultural (archaeological) resources.
- 12. The Facility Owner shall maintain and be listed on an insurance policy that includes liability coverage and property coverage in an amount necessary to cover the value of the commercial solar energy facility in the event the project is damaged or destroyed.
- 13. In addition to the foregoing terms and stipulations within this Ordinance, the Facility Owner/Facility shall comply with all other requirements and standards as set forth in the UDO (i.e. permitting requirements, design and installation requirements, setback requirements, nuisance abatement requirements, and decommissioning requirements, etc.), Statute (i.e. Noxious Weed Act, Solar Site Act, IWPA, RLSA, etc.) and any other applicable Illinois or Federal law (i.e. CWA, any laws administered by the FAA, etc.) or regulation, and any other County and local rules and regulations that are not inconsistent with the Statute.
- 14. As proposed and agreed to by Facility Owner, on or before the completion of the County's final building inspection (of the commercial solar energy facility on the Property), the Facility Owner shall obtain an irrevocable letter of credit or another form of available financial assurance acceptable to the County, in favor of the County, in an amount equal to 100% -instead of the minimum 10% required upfront as outlined in the Agricultural Impact Mitigation Agreement- of the estimated costs of destruction of the Facility as determined in the final deconstruction / decommission plan.
- **BE IT FURTHER ORDAINED**, that the Ordinance shall be in full force and effect immediately upon its adoption.





# ZONING MAP: 8016 Spring Creek (PINS: 12-11-226-001 & 12-12-101-003)





# **FUTURE LAND USE MAP: 8016 Spring Creek (PINS: 12-11-226-001 & 12-12-101-003)**






# ORDINANCE AMENDING CHAPTER 50, ARTICLE V, DIVISION 3 OF THE WINNEBAGO COUNTY CODE OF ORDINANCES TO REGULATE NOISE IN UNINCORPORATED WINNEBAGO COUNTY, ILLINOIS

**WHEREAS**, the County of Winnebago, Illinois (County) has the authority pursuant to 720 ILCS 5/47-5 [Public Nuisance] to declare what are nuisances and abate such nuisances within the unincorporated areas of the County; and

WHEREAS, pursuant to the Illinois Counties Code, 55 ILCS 5/5-12001, the County also has the authority to regulate and restrict location and use of buildings, structures and land for trade, industry, residence and other uses and to regulate and restrict the intensity of such uses, for the purpose of promoting the public health, safety, morals, comfort and general welfare, and conserving the values of property throughout the county; and

**WHEREAS**, the County seeks to regulate noise within the unincorporated areas of the county for the purpose of protecting the public health, safety, morals, comfort, and general welfare of its residents; and

**WHEREAS**, the Operations and Administrative Committee recommends that the Winnebago County Board adopt the proposed amendment to Chapter 50, Article V, Division 3 of the Winnebago County Code of Ordinances attached hereto as Exhibit A; and

**WHEREAS**, the proposed language is intended to declare and abate the nuisance of loud and excessive noise within the unincorporated areas of the County of Winnebago, Illinois.

**NOW, THEREFORE, BE IT ORDAINED**, by the County Board of the County of Winnebago, Illinois, as follows:

- Section 1. That the foregoing recitals shall be and are hereby incorporated as findings of fact as if said recitals were fully set forth herein;
- Section 2. That the Winnebago County Code of Ordinances is hereby amended by adding a Chapter 50, Article V, Division 3 "Noise", as set forth in Exhibit A, which is attached to this Ordinance;
  - Section 3. That this Ordinance shall be in full force and effect immediately upon signing; and

Section 4. That the Clerk of the County Board is hereby directed to prepare and deliver a copy of this Ordinance to the Winnebago County Administrator, the Winnebago County Sheriff, the State's Attorney, and the County Board Office.

### **EXHIBIT A**

CHAPTER 50 – HEALTH AND SANITATION ARTICLE V. – NUISANCES DIVISION 3. – NOISE

Sec. 50-297 - Title.

This division shall be known, cited, and referred to as the "Noise Ordinance of Winnebago County, Illinois."

### Sec. 50-298 - Definitions.

*Instrument* means any musical instrument, whether electronically amplified or not. Instruments include, but are not limited to bells, horns, and drums.

Sound amplification device means any machine or device for the amplification of the human voice, music, sounds emanating from a motor vehicle or any other machinery, or any other noise or sound. Sound amplification devices include speakers, amplifiers, bullhorns, megaphones, radios, tape players, compact disc players, loudspeakers, or any other system that increases volume.

# Sec. 50-299 - Nuisance declared; Applicability.

All noise made in violation of this Ordinance is hereby declared to be a public nuisance. This Ordinance applies to conduct which occurs within the geographic boundaries of the County of Winnebago, Illinois, but outside the corporate limits of a city, village, or incorporated town.

### Sec. 50-300 - Exemptions.

The following sources of noise are exempt from application of this ordinance:

- (a) Noise generated by emergency equipment and work necessary for law enforcement, fire prevention, or for the health, safety, and welfare of the public;
- (b) Noise generated by agricultural, industrial, construction, repair, or remodeling work where the noise from such can be heard from a distance of 100 feet or more from the source of the noise; and
- (c) Noise generated by events or occasions for which a permit (e.g. special event, special use) was applied for and granted.

### Sec. 50-301 - Prohibited noise.

It shall be unlawful and a public nuisance to use or operate a sound amplification device or instrument so that the device or instrument produces loud, unreasonable or unnecessary sounds which can be heard at a distance greater than 100 feet from said device or instrument and which injures or endangers or diminishes the health, peace, safety, or welfare of others, unless one has obtained a permit to do so from the County of Winnebago, Illinois, between the hours of 10:00 pm and 7:00 am Sunday through Thursday and 11:59 pm and 7:00 am Friday and Saturday and on state and federal holidays.

# Sec. 50-302 - Enforcement authority.

Violations of this Ordinance shall be enforced by the Winnebago County Sheriff or his or her designee(s) and, at his or her discretion, may proceed through the administrative adjudication process that is set forth in Chapter 4 of this Code.

### **Sec. 50-303 - Penalties.**

- (a) Any person who violates any provision of this Ordinance shall be deemed to have committed an ordinance violation and shall be fined a minimum of one hundred dollars (\$100.00) and a maximum of five hundred dollars (\$500.00) per violation. Each 24-hour period in which, or during which, a violation occurs shall constitute a separate offense. Second or subsequent violations of Section 50-301 within a one-year period shall incur a penalty of not less than five hundred dollars (\$500.00) and not more than one thousand dollars (\$1,000.00).
- (b) In addition to any penalty provided by this Ordinance, the Winnebago County State's Attorney is authorized to initiate action to obtain injunctive relief in the Circuit Court, including, but not limited to, the issuance of a temporary retraining order and preliminary injunction, in order to abate any such nuisance as enumerated in this Ordinance.
