Will existing flooring be tested for asbestos? Yes. We had samples taking February 24, 2025. Below please see asbestos findings.

Below you will find a list of the areas, the dimensions and what floor materials are currently in the spaces. The areas shaded in red contain asbestos material in the mastic. Winnebago County will have an abatement company remove all affected flooring in these rooms down to the concrete floor. It will be the responsibly of the awarded vendor/flooring company to floor these areas with request flooring in the scope of work.

All areas not highlighted, the awarded vendor/flooring company will need to remove all existing flooring to the concrete floor and floor these areas with requested flooring in the scope of work.

х.	3rd floor staff men's restroom 63 sq. ft. 1 st layer VCT 2 nd ceramic
xi.	3rd floor break area 168 sq. ft. Carpet
xii.	3rd floor elevator area 138 sq. ft.2 layers of VCT
xiii.	4th floor public women's restroom 50 sq. ft. 1 layer of VCT
xiv.	4th floor public men's restroom 42 sq. ft. 1 layer of VCT
xv.	4th floor drug test restroom 108 sq. ft. 1 layer of VCT
xvi.	4th floor break area 60 sq. ft. 2 layers of VCT
xvii.	4th floor elevator area 112 sq. ft. This is carpet
