Public Comment

Chairperson Salgado omitted reading the Public Comment Section of the Agenda due to no one present to speak.

Discuss Legislative and Lobbying Committee Initial Plan and interim Priorities

Introductions were made by committee members to Mercury representatives. Cheri Bustos, Mercury Co-Chair introduced herself and gave some background on her political career, familiarity with Winnebago County and her current position as consultant with the public affairs and lobbying firm Mercury Public Affairs. Ms. Bustos shared the goal of Mercury is to serve the County and be good communicators and shared the history of Mercury and their experience and resources. Zach Koutsky, Mercury Managing Director introduced himself to the committee and gave a brief work background.

Five top priorities were identified by Mercury:

1. PSB Building Funding Gap
2. Quality of Water Wells
3. Roads, Specifically Perryville from Cherry Valley to Roscoe
4. Public Safety with Multiple Sub-Heads
5. Tackling Blight

Chairperson Salgado opened up the meeting to committee members to share their priorities.

Chairperson Salgado spoke about the expectations of the lobbyist and reported the Legislative & Lobbying committee will be responsible for communication and provide progress reports to the County Board. The committee can utilize the committee structure to highlight lobbyist or grant related items within the appropriate committees.

- Winnebago County Board Chairman Chiarelli and Ms. Dokken, Director will be the point of contact for Mercury.
- Mercury will create a report as an action item on the top priorities and give a presentation to the full County Board once the Grant Writer is secured.
- Chairman Salgado and County Board Chairman Chiarelli will create a schedule and determine the frequency of reporting.
- Ms. Dokken will follow up with Hannah on D-1 and D-2 reporting.
- Mercury requested a County Board Schedule of Meetings, an overview of the PSB and Synopsis of the Solid Waste Management Landfill.
- Mercury will provide the House and Senate calendars for the remainder of 2023.
- Mercury will prepare a letter from Chairman Chiarelli to Federal legislators announcing Mercury was hired to represent Winnebago County.
- Hold regular meetings to meet directly with legislators and invite the legislators to attend a County Board meeting to address issues.
- Host a Legislative & Lobbyist breakfast meeting with legislators to meet Mercury representatives.
- Schedule meetings with Federal legislators.

- Mercury will facilitate Legislative & Lobbying committee members to meet with the Danish Ambassador in February 2024 in Washington D.C. Mercury offered to coordinate arrangements and appointments.
- NACo holds a Legislative Conference in Washington, D.C. in February 2024. Mercury offered to coordinate arrangements and appointments.

Chairperson Salgado called for questions, comments or thoughts.
