- There was a discussion regarding an item that the State or Federal government needed from the County to identify procurement minority businesses and how to report them.
- There was a discussion regarding Juneteenth. The Board previously voted to not make it a holiday in 2022. It will be presented to the Board during the budget process to have Juneteenth be a County holiday in 2023.
- The Diversity Council was trying to make sure they were providing the representation for job opportunities within the minorities, trying to push on the procurement side for minority owned businesses and see if there was a policy in place.
- Starting this year the County will track their vendors as far as small business minority status, women owned businesses and veteran status. Information will be posted on the website.
- Chairman Chiarelli asked for the Council's assistance in obtaining a larger pool of candidates for appointments to the County Board. It was recommended to reach out to different communities and organizations as they know individuals who are highly qualified.
- The HR Department is working on diversity training.
- "Eliminate Racism 815" was discussed.
- There was a discussion of possibly having diversity on faith during the prayer and pledge at some future County Board meetings.

Public Comment

Treasurer Report

- Two checks were written, check #1079 written to RAMM for \$450.00 in payment for a banquet and a second check not named.

Motion passed by unanimous voice vote.

Other Items

- Chairman Chiarelli was sent a request to advise the committee on how to make improvements to the committee and what can be provided to help. Chairman Chiarelli was not in attendance.
- Mr. Salgado reported the Diversity Council is part of the Winnebago County as a whole with at least two board members. The committee needs to look at Bylaws for structure. The purpose is to ensure that the county as a whole has a representation of the whole county, by hiring practices, minority women's businesses, etc. Outside of the community, the committee has made donations to other causes, such as Juneteenth, promoting diversity, for the county as a whole, not just one organization but across the board with other organizations. The committee needs to have more diligence on meeting regularly and what to do going forward. In the past, the procurement officer was invited to the committee and spoke about best practices for bidding to attract minority and women in business and also HR when it comes to hiring. The committee is hoping the Chairman can work with the committee to attain the goals of the committee.
- Mr. Wilson spoke about the purchasing aspect of the County to try to include minorities and others. Mr. Rickert advised that Purchasing was directed to start tracking vendors for small business minority and women owned businesses that will be posted on the website. Mr. Wilson would like to see updated statistics showing a comparison of the past to the present for the past quarter through September 2022.
- Ms. Crozier noted on the HR application, race/ethnicity is a volunteer question and the majority of people do not respond to the question. A suggestion was made to utilize zip codes to collect statistics.

Motion made by Ms. Redd to have Tim Nabors act as the Chairman of the Diversity Council. Second: Mr. Salgado.

Motion carried with unanimous voice vote.

- The suggestion was made to have Maria Fernandez act as Vice Chairperson. Maria will be nominated and voted in at the next Diversity meeting.
- The Diversity Committee is a standalone committee. Board members discussed the establishment of the committee through a Resolution in the past. Ms. Redd and other committee members will check to see if they have the paperwork that can be sent to the County Chairman's office. The Diversity Committee is looking for Chairman Chiarelli to recognize the Diversity committee as part of the Winnebago County Board.

Motion made by L.C. Wilson to meet quarterly. Second: All other committee members. Motion carried with unanimous voice vote.

• Tommy Meeks mentioned his wife, Ms. Evelyn Meeks has received the School Board Member of the Year award for the State of Illinois. She is in the Harlem School District. Mr. Rickert will notify the Chairman's assistant to create a Proclamation recognizing the achievement and service of Ms. Meeks. • Mr. Rickert will pass on the information discussed during the committee meeting to Chairman Chiarelli.
