## **BUILDING ENTRANCE AGREEMENT**

This building entrance agreement ("Agreement") is made this \_\_\_\_ day of \_\_\_\_\_, 2017, by and between Unite Private Networks, LLC, a Delaware Limited Liability Company ("UPN"), and the County of Winnebago, the owner ("Owner").

Whereas, Rockford School District 205 ("School District") utilizes a fiber connection for WinGIS access, which is located in the Winnebago County Administration building, 404 Elm Street, Rockford, Illinois; and

Whereas, the School District has contracted with a new vendor, UPN, for their fiber infrastructure and desires to replace the existing fiber connection at 404 Elm Street; and

Whereas, the School District currently provides classes at the Winnebago County Juvenile Detention Center located at 5350 Northrock Drive, Rockford, Illinois, using a VPN connection; and

Whereas, the School District desires to have UPN install a fiber connection at the Juvenile Detention Center to better support the staff and classes at that location.

With this Agreement, Owner grants permission to UPN to make entrance to, install telecommunications equipment in and provide telecommunications services including, but not limited to, telecommunication, data transmission and/or other similar services ("Services") to the real properties located at 5350 Northrock Drive, Rockford, Illinois, and 404 Elm Street, Rockford, Illinois, such real properties commonly known as Winnebago County Juvenile Detention Center and Winnebago County Administration Building (Collectively, the "Premises") for the purpose of supporting the connectivity of the School District.

NOW THEREFORE, in consideration of the covenants contained herein and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. UPN hereby agrees to install, maintain, repair, replace, service and operate a telecommunications system (the "System") in the Premises at no charge to the Owner, consistent with the applicable standards of the Federal Communications Commission (the "FCC") and any other applicable state or local regulatory requirements. UPN shall have all rights, title and ownership interest in all of the system installed by UPN during the Term of the Agreement. The System shall not be used by Owner or any third party during the term of the Agreement without the prior written consent of UPN.
2. Owner hereby agrees that it will permit UPN, its employees and authorized contractors reasonable, non-exclusive access to the Premises during hours the Premises are open to the public to perform installation and subsequent service, testing, repairs, connects or disconnects on the System as may be required.
3. UPN shall indemnify, defend and hold harmless Owner against costs and liabilities caused by the installation and maintenance of the System. In no



event will either party be liable for special, exemplary, punitive, indirect, consequential or incidental damages, including but not limited to, damages for loss of use, lost profit, loss of business or goodwill, or other financial injury arising out of or in connection with the System. UPN's liability to Owner for damages from any cause whatsoever and regardless of the form of the action, whether in contract, in tort (including negligence or strict liability) or by statute, shall be limited to direct and actual damages.

4. This Agreement shall commence on the date hereof and shall terminate upon the earlier of (i) the default by any Party of a material condition of this Agreement or (ii) the final expiration or the earlier termination of the franchise to provide the Services in place with the city which the Premises is located (inclusive of any renewal thereof) or (iii) expiration or termination of the agreement for fiber connectivity between the School District and UPN (inclusive of any renewal thereof) (the "Term").
5. UPN and Owner shall cooperate and coordinate with one another in the design, installation and construction of the System in order to achieve such design and construction in a timely, effective and cost-efficient manner. UPN and Owner shall keep one another fully and timely informed throughout the course of design and construction.
6. Owner will not use, or permit others to use, any equipment that causes interference or is otherwise incompatible with the System, the reception equipment, or UPN's right to provide the Services under this Agreement, nor shall Owner extract, nor permit others to extract any unauthorized signals from the System. Owner shall not move, disturb, alter, change or connect any other device to the System nor authorize, permit or allow anyone to do so.
7. All equipment and components of the System placed by UPN within the Premises shall be at UPN's sole risk and expense, except for any gross negligence or willful misconduct of Owner or those for whom Owner is responsible at law. All work completed by UPN pursuant to this Agreement shall be completed in a workmanlike manner. UPN shall ensure the System is installed in a safe and proper manner so as to pose no known hazard to safety of persons or property with respect to persons and property in or about the Premises.
8. UPN shall have ninety (90) days after the termination or expiration of this Agreement in which to remove all parts of the System from the Premises and shall restore the Premises to their original condition, reasonable wear and tear excepted.
9. Owner shall have no liability for theft or burglary, or for damage done by unauthorized persons in the Premises unless caused by the gross negligence or willful misconduct of Owner, its agents, employees or invitees.

10. Prior to commencement of any work in the Premises, UPN shall obtain and shall maintain throughout the Term of this Agreement and for so long as UPN shall have equipment in the Premises, the following insurance, at its own expense, in the amounts not less than those specified below:

- Workers' Compensation Insurance in accordance with the laws of the State of Illinois;
- Employer Liability Insurance in accordance with the laws of the State of Illinois;
- Comprehensive general liability insurance, for injury, death or property damage arising out of the work provided pursuant to this Agreement. This insurance shall include Bodily Injury Liability and Property Damage Liability Insurance sufficient to protect UPN while performing work covered by this Agreement from any and all claims for damages for bodily injury, including accidental death, as well as any and all claims for property damage which may arise from UPN's operations under this Agreement, whether such operations be by UPN or by any subcontractor or by anyone directly or indirectly employed by either of them. Such insurance shall be a combined single limit bodily injury and property damage for each occurrence and shall not be less than \$2,000,000 per occurrence.

11. This Agreement constitutes the complete agreement of the parties relating to the matter specified in this Agreement and supersedes all prior representations or agreements, whether oral or written, with respect to such matters. This agreement may not be amended except by a written instrument executed by all parties. This Agreement shall be binding upon the parties hereto and their successors and assigns. Any party may transfer or assign this Agreement. This Agreement shall be governed by the laws of the State of Illinois without regard to its choice of law provision as to all matter hereunder. This Agreement may be executed in counterparts, each of which shall be an original, and all of which together shall be deemed to constitute one original agreement.

## **LEASE ADDENDUM**

# Executive Summary

**Background:** The WinCo Metropolitan Area Network (WINMAN) contains a single legacy Cisco Systems ASA 5545 firewall. In Cisco speak - **ASA** stands for **Adaptive Security Appliance**. In brief, Cisco **ASA** is a **security** device that combines firewall, antivirus, intrusion prevention, and virtual private network (VPN) capabilities. It provides proactive threat defense that stops attacks before they spread through the network. The ASA 5545 is the single firewall in our WINMAN mediating traffic between trusted sites and deterring cyber-attacks.

The ASA 5545 is end-of-life whereas no new support contract is obtainable as of December 2017. This product becomes obsolete 9/30/2018.

In addition to obsolescence of this device, funding challenges have kept us from installing redundant firewalls for fail over purposes. While the Cisco System ASA 5545 has stellar reliability, failure of this device produces a single-point-of-failure.

**Recommendation:** The Winnebago County Administrator along with the Department of Information Technology recommends procuring and deploying the Check Point redundant firewall solution from Software Technologies LTD., 959 Skyway Road Suite 300, San Carlos, CA 94070. This firewall solution is next-generation in that it uses the most recent network threat algorithms and threat extraction techniques available. In addition, the solution we have designed includes redundancy whereas a single-point-of-failure is eliminated.

Check Point feature summary: firewalling, intrusion protection, 2Gps+ throughput, static virtual private tunnels, client virtual private tunnels and antivirus. This solution is expandable to provide web site filtering and analytics.

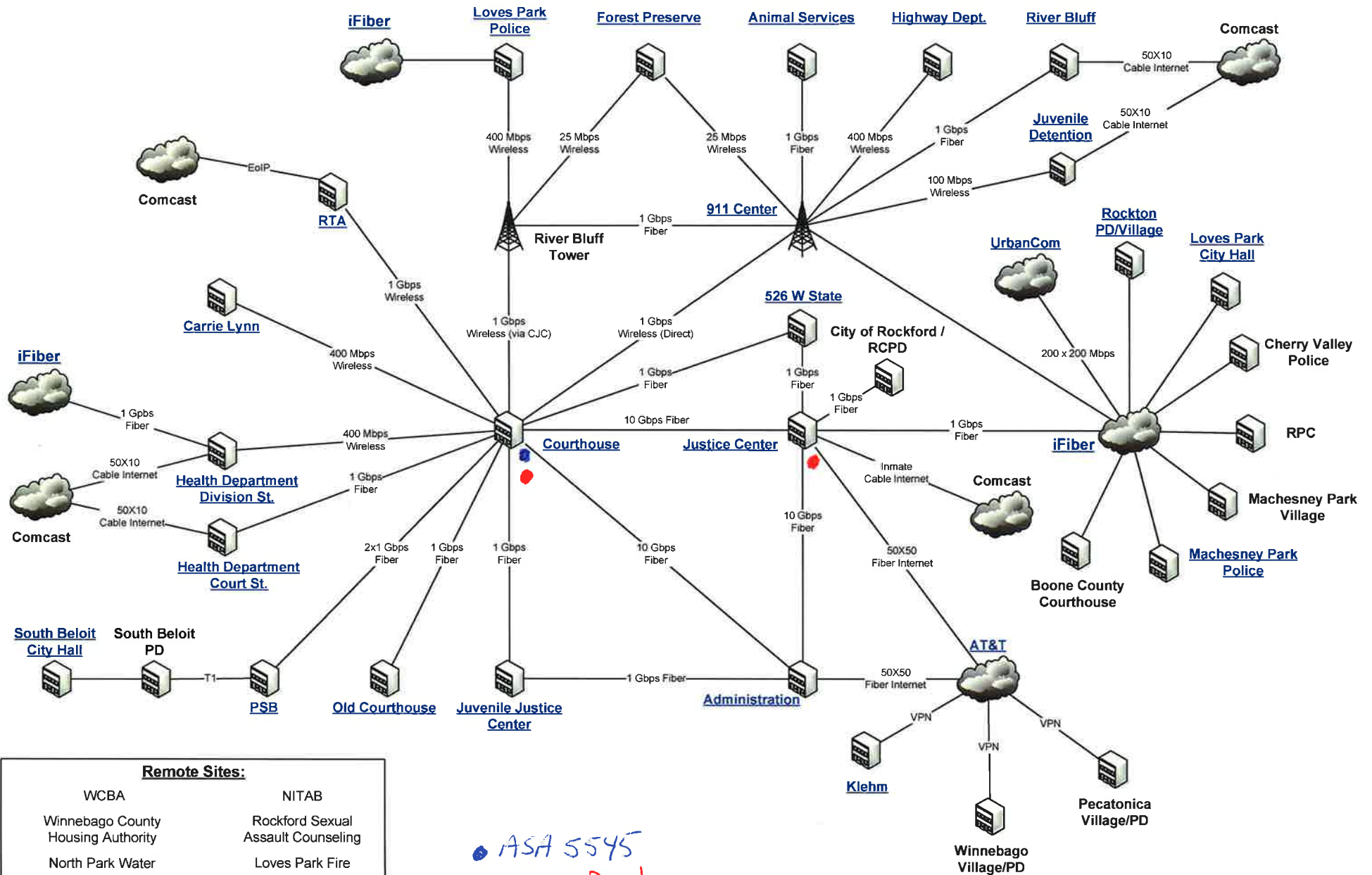
