## Background Information:

The County maintains a small fleet of vehicles known as Car Pool for use by employees. Now that Covid travel restrictions have ended, the Car Pool fleet is back in demand for travel. As far as assigned Vehicles, the building inspectors, on average, drive 1,000 to 2,000 per month, per vehicle.

## Car Pool Fleet Issues:

- ✓ The Car Pool FY22 budget is estimated to be short by up to \$9,000 for Gasoline & Oil line item (42240)
- ✓ Because of the age and mileage on many of the vehicles, more general maintenance and repairs are being done. The cost of parts has also gone up. We estimate a need for no more than \$9000 in additional funds for Automobile Repair and Maintenance budget line item (43731).
- ✓ The current vehicle, 2019 Ford Escape, assigned to the Chairman needs to be rotated back in the Car Pool Fleet and a new 2022 Ford Edge purchased for the Chairman to use (46410). Delivery is averaging a minimum of 3 to 4 months.

**WHEREAS**, the Winnebago County Board adopted the “Annual Budget and Appropriation Ordinance” for the fiscal year ending September 30, 2022 at its September 30, 2021 meeting; and,

**WHEREAS**, 55ILCS 5/6-1003(2014), states, “After the adoption of the county budget, no further appropriations shall be made at any other time during such fiscal year, except as provided in this Act. Appropriations in excess of those authorized by the budget in order to meet an immediate emergency may be made at any meeting of the board by a two-thirds vote of all the members constituting such board, the vote to be taken by ayes and nays and entered on the record of the meeting.”

**NOW, THEREFORE, BE IT ORDAINED**, that the County Board deems that pursuant to the provisions as set forth in 55ILCS 5/6-1003(2014), certain conditions have occurred in connection with the operations of the County which are deemed to be immediate emergencies; therefore the increases detailed per the attached Request for Budget Amendment are hereby authorized for Amendment **#2022-018 Car Pool**.
