Proclamation In Recognition of Juneteenth National Freedom Day

WHEREAS, Juneteenth, or Juneteenth National Freedom Day, commemorates the traditional observance of the end of slavery in the United States and is observed annually on June 19th; and

- WHEREAS, President Abraham Lincoln declared that "in giving freedom to the slave, we assure freedom to the free honorable alike in what we give, and what we preserve. We shall nobly save or meanly lose, the last best hope of earth;" and
- WHEREAS, on January 1, 1863, using his war powers as President, Abraham Lincoln signed the Emancipation Proclamation, providing that all persons held as slaves within any State or designated part of a State "shall be then, thenceforward, and forever free;" and
- WHEREAS, more than two years would pass before news reached slaves living in Texas, when on June 19th, 1865, Union Major General Gordon Granger and his regiment arrived in Galveston and spread the word that slavery had been abolished; and
- WHEREAS, the following year, the first official Juneteenth celebrations took place in Texas and have continued across the United States throughout the years since; and
- WHEREAS, Juneteenth is the oldest nationally celebrated commemoration of the ending of slavery; and since then, the State of Illinois, 47 other states, the District of Columbia, and the Federal Government have declared it an official holiday; and
- WHEREAS, Juneteenth is an important opportunity to honor the principles of the Declaration of Independence and celebrate the achievements and contributions Black Americans have made, and continue to make, in Winnebago County and across our Nation.

NOW, THEREFORE, I, Joseph Chiarelli, Chairman of the Winnebago County Board do hereby proclaim the day of June 19th to be "Juneteenth National Freedom Day" in Winnebago County, and urge all citizens to commemorate and celebrate June 19th as such.

The County maintains a small fleet of vehicles known as Car Pool for use by employees. Now that Covid travel restrictions have ended, the Car Pool fleet is back in demand for travel. As far as assigned Vehicles, the building inspectors, on average, drive 1,000 to 2,000 per month, per vehicle.

Car Pool Fleet Issues:

- ✓ The Car Pool FY22 budget is estimated to be short by up to \$9,000 for Gasoline & Oil line item (42240)
- ✓ Because of the age and mileage on many of the vehicles, more general maintenance and repairs are being done. The cost of parts has also gone up. We estimate a need for no more than \$9000 in additional funds for Automobile Repair and Maintence budget line item (43731).
- ✓ The current vehicle, 2019 Ford Escape, assigned to the Chairman needs to be rotated back in the Car Pool Fleet and a new 2022 Ford Edge purchased for the Chairman to use (46410). Delivery is averaging a minimum of 3 to 4 months.

Description of Business & Project:

Hemp Center of Northern Illinois, LLC (Hemp Center) was formed in 2019. It is a female owned retailer of CBD and related products located on Rockford's east side. Laura Renner is the majority-owner with 90% and Anthony Artale owns 10%, who also owns Artale Wine Company. Ms. Renner also owns Josef's, a fine dining restaurant, Anthony Artale, owner of Artale Wine Company, and the new location of Hemp Center, will all be located in close proximity to one another near the corner of Spring Creek Road and North Perryville Road. Since Ms. Renner purchased this business (Hemp Center) in January 2020 with funding from RLDC, she has had an exemplary loan repayment history with loan from RLDC, establishing business financial credibility. The Hemp Center storefront will be adjacent to Josef's, where she will have approximately 2,500 square feet (~1,000 square feet) more to add a health food café and expand her retail presence. By locating next to Josef's, she will not need to replicate food preparation equipment as that is already established at Josef's, thus saving funds in addition to utilizing some of their equipment and staff. This provides an additional advantage over the business proximities to one another. Ms. Renner and Mr. Artale are planning regular co-branding events where Artale will feature wine dinners to complement Hemp Center's nutritious food. Hemp Center plans on hiring on 3 FTE (Full Time Equivalent) employees that would bring her total staff to 6 FTE employees within 2 years. This would equate to the County's investment of \$20,000 per employee for the loan, not including sales tax dollars or property tax revenues. Aside from shared use of equipment for prep, it would also allow for joint use of Josef's patio for the lunch time patrons as the Hemp Centers hours are from 10 AM-5 PM and Josef's hours are 4 PM-10 PM. As part of the overall loan, the federal funds (\$30,000), Ms. Renner will sign an affidavit affirming that she will not sell THC or other products considered illegal by the federal government.

The loan request is for the relocation and expansion of operations to a former Subway (sandwich shop) site, which had left behind some of the food prep equipment that will be utilized. The funds would be used to renovate and create a warm and inviting space, purchase of equipment still needed, and operating capital to support a robust initial marketing campaign and sustain business until it generates sufficient organic cash flow. Laura Renner will be a co-borrower/personal guarantor. Based on the previous sales, the projected sales are estimated between approximately \$20,000 and \$25,000 in new additional sales tax revenue to the state and local governments.






REVOLVING LOAN FUND PROCESS IN A NUTSHELL

(Assuming approval at each step)





Ignorance on the part of the Proposer shall in no way relieve him of the obligations and responsibilities assumed under the proposal.
- B. Should a Proposer find discrepancies or ambiguities in, or omissions from, the specifications, or should he be in doubt as to their meaning, he shall at once notify the County at purchasing@purchasing.wincoil.gov by the Schedule of Events deadline.

1.4 INTERPRETATIONS, CLARIFICATIONS, AND ADDENDA

No oral interpretations will be made to any Proposer as to the meaning of the documents. Any inquiry or request for interpretation received *in writing* by the date specified, in the Schedule of Events, emailed to purchasing@purchasing.wincoil.us

All such changes or interpretation will be made in writing in the form of an addendum and, if issued, shall be posted on the County's website no later than <u>five (5) business days</u> prior to the established Proposal due date. It shall be the Proposer's sole responsibility thereafter to find and download the addendum.

Each Proposer MUST acknowledge receipt of such addenda on the Proposal Signature Form. All addenda are a part of the documents and each Proposer will be bound by such addenda, whether or not received by him. It is the responsibility of each Proposer to verify that he has received all addenda issued before proposals are opened.

1.5 GOVERNING LAWS AND REGULATIONS

The Proposer is required to be familiar with and shall be responsible for complying with all Federal, State, and local laws, ordinances, rules, and regulations that in any manner affect the work. Knowledge of occupational license requirements and obtaining such licenses for Winnebago County and municipalities within Winnebago County are the responsibility of the Proposer.

1.7 SUBMISSION OF PROPOSALS

- A. Proposals shall be submitted to Winnebago County at the designated location not later than the time and date for receipt of proposals indicated in the RFQ solicitation, or any extension thereof made by Addendum. Winnebago County's representative authorized to open the proposals will decide when the specified time has arrived and no Proposals received thereafter will be considered. Proposals received after the time and date for receipt of Proposals will be returned unopened.
- B. Winnebago County Purchasing Department receives proposals by paper only. Please DO NOT email or Fax proposals.
- C. Each Proposer shall submit with his Proposal the required evidence of his qualifications and experience.

1.8 CONTENT OF SUBMISSION

The proposal submitted to this RFQ shall be in paper form in a tabbed binder with one digital PDF format on a memory stick.

Statements submitted without the required information will <u>not</u> be considered. Proposals shall be organized as indicated below. The Proposer should not withhold any information from the written proposal in anticipation of presenting the information orally or in a demonstration, since oral presentations or demonstrations may not be solicited. Each Proposer must submit adequate documentation to certify the Proposer's compliance with the County's requirements. Proposers should focus specifically on the information requested. Additional information, unless specifically relevant, may distract rather than add to the Proposer's overall evaluation.

The Proposer shall provide at least three written references or the name and current contact information from an Illinois local government or other governmental entity for which the Proposer has provided the same or similar services during the past three years. Each reference shall include, at a minimum, the information listed above.

Tab 3. Services Provided

Proposer shall provide a listing of all the services, with specific descriptions that will be offered under the agreement that will provide evaluators with insight about the qualifications, fitness, and abilities of the firm.

The Proposer shall describe the composition and structure of the firm (sole proprietorship, corporation, Limited Liability Company, partnership, joint venture) and include names of persons with an interest in the firm that might have any affiliations with Winnebago County government.

The Proposer shall include a list of the proposed staff that will perform the services required if awarded a contract. An organizational chart should be included in this Section. The Proposer shall also include a resume for each member of the project team identifying his/her role on the team and any qualifications relevant to the assigned position. Include in this Section the location of the main

office and the location of the office proposed to work on any awarded County project.

Proposer shall describe its use of technology in the office or in the field which may be used on this project. List any specific hardware and software currently in use or planned.

Tab 5. Company Information

The Proposer will provide the following information:

- 1. A list of the officers and directors of the entity
- 2. The number of years the person or entity has been operating and, if different, the number of years it has been providing the services, goods, or construction services called for in the SOW (include a list of similar projects)
- 3. The number of years the person or entity has operated under its present name and any prior names
- 4. Identify how many professionals are employed by the firm
- 5. Identify which services your firm will provide in-house or will subcontract
- 6. Customer references (minimum of three), including name, address, email and telephone
- 7. Proposer shall produce evidence of proper licensing to perform the services described herein. Copies of all professional and occupational licenses shall be included in this Section.

Tab 6. County Forms

Proposer shall complete and execute the forms specified in the RFQ (Proposal Signature Form, Business References, W-9, Suspension and Debarment Certification Form) and shall include them in the appropriate Tabbed Section; failure to provide executed documents may result in Proposer being determined to be not fully responsive to the RFQ.

1.9 MODIFICATION OF PROPOSALS

Written modification will be accepted from firms if addressed to the entity and address indicated in the Request for Qualifications and received prior to Proposal due date and time. Prior to the time and date designated for receipt of Proposals, any Proposal submitted may be modified by delivery to the County Purchasing Department of a complete Proposal as modified. All emails shall be marked "Modified Proposal" delivery shall comply with requirements for the original proposal.

1.10 RESPONSIBILITY FOR PROPOSAL

The Proposer is solely responsible for all costs of preparing and submitting the proposal, regardless of whether a contract award is made by the County. *Unless otherwise specified by the Proposer, the County has no fewer than one hundred twenty (120) day to make a final selection.*

1.11 RECEIPT AND OPENING OF PROPOSALS

The properly identified Proposals received on time will be opened by the County Purchasing Department. Any Proposal not received by the Purchasing Department on or before the deadline for receipt of proposals designated in the solicitation or Addendum(s) will not be opened.

1.12 EVALUATION OF PROPOSALS

Proposals will be evaluated on experience in doing projects of a similar nature and

adherence to specifications. These criteria are to be utilized in the evaluation of qualifications for development of the short list of firms to be considered for oral interviews and/or potential negotiations. Individual criteria may in all probability be assigned varying weights at the County's discretion to reflect relative contract importance. Firms are required to address each evaluation criteria and to be specific in presenting their qualifications.

The County reserves the right to reject any and all proposals and to waive technical errors and irregularities as may be deemed best for the interests of the County. Proposals that contain modifications, are incomplete, unbalanced, conditional, obscure, or that contain additions not requested or irregularities of any kind, or that do not comply in every respect with the solicitation instruction and documents, may be rejected at the option of the County.

Please note that a proposal may be rejected as non-conforming, non-responsive or the proposer may be deemed not responsible in which case the amount of points will become irrelevant to the final selection. Tab 5 and Tab 6 do not have a point value; however, failing to answer the required questions or include the required documents and forms shall be grounds for rejection of the proposal. In addition to the points as set out above, the evaluation of proposals shall include, but not be limited to, the criteria set forth in this RFQ.

The Evaluation Committee may conduct oral interviews with and/or require presentations as set forth above in the Schedule of Events, of the Proposer(s) who submits acceptable or potentially acceptable Qualifications. Such Proposer shall be accorded fair and equal treatment with respect to any opportunity for interviews. During the course of such oral interviews, the Evaluation Committee shall not disclose any information derived from one submittal to any other firms.

1.13 FINAL SELECTION

On the basis of the proposal evaluations, oral interviews (if conducted), the County shall select one firm which it determines to be the most qualified to provide services regarding a specific project. The County shall then contact the firm ranked most preferred and attempt to negotiate a contract at a fair and reasonable compensation, taking into account the estimated value, scope, complexity, and firms nature of the services to be rendered.

Selection shall be made of the Professional deemed to be fully qualified and best suited among those submitting Qualifications, on the basis of the factors involved in the RFQ. It is the intent of

the County of Winnebago to select the firm whose Qualifications meet or exceed the requirements as outlined herein. Information and/or factors gathered during interviews, presentations, negotiations and any reference checks, in addition to the evaluation criteria stated in the RFQ, and other information or factors deemed relevant by the County, shall be used in the final selection decision.

1.14 NEGOTIATIONS

The County shall prepare a written description of proposed services to be used as a basis for negotiations and shall negotiate a contract with the highest qualified firm(s) at compensation and for a term that the County determines in writing to be fair and reasonable. In making this decision, the County shall take into account the estimated value, scope and complexity and firm's nature of the services to be rendered. Also, consider how much subcontract the firm(s) will need to use for a project.

If the County is unable to negotiate a satisfactory contract with the firm(s) which is most preferred, negotiations with that firm(s) shall be terminated. The County shall then begin negotiations with the firm which is next preferred.

If the County is unable to negotiate a satisfactory contract with any of the selected firms, the County shall re-advertise the project.

1.15 NOTICE OF UNACCEPTABLE SUBMITTAL

When the Evaluation Committee determines a Proposer's qualification to be unacceptable, such firm shall not be afforded an additional opportunity to supplement its original proposal.

1.16 AWARD OF CONTRACT

- A. The County reserves the right to waive any informality in any proposal, or to re- advertise for all or part of the work contemplated. If proposals are found to be acceptable, written notice will be given to the selected Proposer of the award of the contract. The County reserves the right to reject any and all proposals.
- B. If the award of a contract is annulled, the County may award the contract to another Proposer(s), or the work may be re-advertised or may be performed by other qualified personnel as the County decides.
- C. A contract will be awarded to the Proposer(s) deemed to provide the services which are in the best interest of the County.
- D. The County also reserves the right to reject the proposal of a Proposer who has previously failed to perform properly or to complete contracts of a similar nature on time.

1.17 CERTIFICATE OF INSURANCE AND INSURANCE REQUIREMENTS

The Proposer shall be responsible for all necessary insurance coverage as indicated below. Certificates of Insurance must be provided to Winnebago County within fifteen (15) days after award of contract, with Winnebago County listed as additional insured as indicated. If the proper insurance forms are not received within the fifteen (15) day period, the contract

may be awarded to the next selected Proposer/Proposer. Policies shall be written by companies licensed to do business in the State of Illinois and having an agent for service of process in the State of Illinois. Companies shall have an A.M. Best rating of VI or better.

Winnebago County shall be named as an Additional Insured on the General Liability and Vehicle Liability policies.

1.18 HOLD HARMLESS CLAUSE

The Proposer covenants and agrees to indemnify, hold harmless and defend Winnebago County, its Board members, officers, employees, agents and servants from any and all claims for bodily injury, including death, personal injury, and property damage, including damage to property owned by County, and any other losses, damages, and expenses of any kind, including attorneys' fees, costs and expenses, which arise out of, in connection with, or by reason of services provided by the Proposer or any of its Subconsultant(s) in any tier, occasioned by the negligence, recklessness, or intentionally wrongful conduct of the Proposer, or its Subconsultant(s) in any tier, their officers, employees, servants or agents. In the event that the completion of the project (to include the work of others) is delayed or suspended as a result of the Proposer's failure to purchase or maintain the required insurance, the Proposer shall indemnify the County from any and all increased expenses resulting from such delay. Should any claims be asserted against the County by virtue of any deficiency or ambiguity in the plans and specifications provided by the Proposer, the Proposer agrees and warrants that Proposer shall hold the County harmless and shall indemnify it from all losses occurring thereby and shall further defend any claim or action on the County's behalf.

Once approved by the County, time limits established by the schedule shall not, except for reasonable cause, be exceeded by Proposer or County. With County's approval, Proposer shall adjust the schedule, if necessary, as the Project proceeds until commencement of construction.

Proposer shall, at appropriate times, contact governmental authorities required to approve construction documents and entities providing utility services to the Project. In designing the Project, Proposer shall respond to applicable design requirements imposed by such governmental authorities and by such entities providing utility services.


