(24-004) CHAIRMAN TASSONI MADE A MOTION TO APPROVE A Resolution Authorizing the Award of Bid for Elevator Road Resurfacing and for Appropriating RBI Funds (Section: 23-00720-00-RS) Mr. Von Bergen petitioned the PWC to approve this bid. This resolution also appropriates Rebuild Illinois Funds (RBI) for construction and materials testing. The Highway Department staff feels it is a competitive bid. The project includes widening, paving the shoulders, pipe culvert replacements, resurfacing the road and installing rumble strips along the edge and centerline of pavement. SECONDED BY MR. SCROLL AND MR. MCCARTHY. MOTION APPROVED BY ALL PRESENT.
