MINUTES:

A. Call to Order – MR. TASSONI CALLED THE MEETING TO ORDER AT 5:00 P.M.

C. Approval of Minutes – CHAIRMAN TASSONI MADE A MOTION TO APPROVE the July 22, 2024 Meeting Minutes. SECONDED BY MR. WEBSTER AND MR. SCROL. MOTION APPROVED BY ALL PRESENT Closed Meeting - None

New Legislation –

(24-034) CHAIRMAN TASSONI MADE A MOTION TO APPROVE A Resolution Authorizing the Approval of an Intergovernmental Cooperation Agreement with the Greater Rockford Airport Authority for Kishwaukee Road Improvements (Section 24-00731-00-WR). Mr. Molina stated that this Agreement is to widen an approximate 1,000-foot section of Kishwaukee Road to three lanes including a left turn lane adjacent to property owned by the



Airport. Kishwaukee Road carries a considerable amount of truck traffic at all times of day and this improvement will increase safety to all road users. This project is budgeted and construction is planned for the summer of 2025. The Greater Rockford Airport Authority is funding the engineering (approximately \$90,000) and will reimburse the County for \$100,000 of the construction cost. SECONDED BY MR. MCCARTHY. MOTION APPROVED BY ALL PRESENT.

(24-035) CHAIRMAN TASSONI MADE A MOTION TO APPROVE A Resolution Authorizing the Award of Bid for Moate Road Shoulder Widening and Paving (Section 24-00000-05-GM). Mr. Molina informed that this bid was opened on Monday, August 12th. This is a three-mile section of roadway that connects IL-75 with IL-70, it is in poor condition and carries a substantial amount of truck traffic. The project will widen the road and pave the shoulders. The road will be resurfaced in the future under a separate contract. Construction is planned for fall of 2024. SECONDED BY MR. WEBSTER. MOTION APPROVED BY ALL PRESENT.

(24-036) CHAIRMAN TASSONI MADE A MOTION TO APPROVE A Resolution Authorizing an Application to the Illinois Transportation Enhancement Program (ITEP) for Funds to Develop a Multi-use Path Along or Near Riverside Boulevard to Connect the Perryville Path to the Paladin Parkway Path (Section 24-00733-00-BT). Mr. Molina informed that this Resolution is required by the State to submit an application for ITEP funds. The ITEP application will include engineering that will ultimately connect the Perryville Path to the path on Paladin Parkway by Sportscore II and across I-90/I-39. The application deadline is September 30, 2024. SECONDED BY MR. WEBSTER. MOTION APPROVED BY ALL PRESENT.

 - i. Elmwood Road Funding Mr. Molina informed the PWC that we received \$210,000 in Truck Access Route Program (TARP) Funding for Elmwood Road from Owen Center Road to IL Route 2. The intersection of Owen Center and Elmwood Rd will be improved as part of a separate contract for which the County received safety funds. The Elmwood Road Project is scheduled to begin next year.

- ii. Riverside Boulevard Project Update Mr. Molina informed the PWC that we have received approximately 10 million dollars in federal funding; in addition to the local match (\$2 to \$3 million). We will be opening bids for Materials only in early October. These materials include traffic signal equipment, street lights, storm sewer and other drainage items. This is due to COVID dollars awarded to the County for this project in the amount of about \$668,000 which need to be committed by September 30 of 2024.
