Corrected wasteful spending and or incurring of expenses and worked on long term planning and saving. The Board has supported changes not only on public's right to speak; but in all aspects. All the above plus Record Disposal has to be addressed- was a change in Clerk who did not finish addressing that task. Grant writing and Continue with improvements to the premises.

It will take legislative action to change how Township government is organized which would result in more funding for the Road District. Provide more funding to Township Road Districts for road maintenance and equipment.
